MEMORANDUM OF UNDERSTANDING

AND

SHAH & ANCHOR KUTCHHI ENGINEERING COLLEGE, Mahavir Education Trust Chowk, W.T. Patil Marg, Chembur, Mumbai - 400 088, (hereinafter referred to as 'SAKEC') represented herein by Shri. Navinbhai K. Shah, Managing Trustee, Mahavir Education Trust.

IITEMUM and SAKEC are jointly referred to as 'Parties' in this MoU.

WHEREAS: IITEMUM and SAKEC have expressed mutual interest in setting up an "SAKEC IETE Center of Excellence" at the premises of SAKEC.

In consideration of the mutual obligations herein contained, the parties agree as follows:

WHEREAS:

A) The Parties intent to cooperate and focus their efforts on cooperation within area of Skill based training, Education and Research in the area of Telecommunication and allied domains.

B) Both Parties, being legal entities in themselves desire to sign this MoU for advancing their mutual interests.

CLAUSE 1 CO- OPERATION

1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the institution and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.

1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities and expertise of the IETE members and their contacts in Industry and Academia in developing training programs for students and faculties of academic institutions for the needs of the industry.

CLAUSE 2 SCOPE OF THE MOU

2.1 Certificate courses: The budding graduates from the institutions could play a key role in technological up-gradation, innovation and competitiveness of an industry. Conduction of certificate courses for the students and faculties' knowledge upgradation and the evaluation of the gained knowledge adds value to the knowledge base. Both parties believe that close co-operation between the two would be of major benefit to the academic community to enhance their skills and knowledge.

2.2 Skill Development Trainings: Industry and Institution interaction will give an insight in to the latest developments / requirements of the industries; the first party can guide the faculty and students of the second party to visit the organizations & industries of their contact.

2.3 Research and Development: Both parties have agreed to carry out the joint research activities in the above fields.

2.4 Guest Lectures & Faculty Development Programs: First Party to extend the necessary support to the second party to deliver guest lectures for students & staff; coordinate for Faculty Development Programs to the staff, who will enroll with the programmes conducted by SAKEC IETE COE in Telecommunication & allied domains.

CLAUSE 3 VALIDITY

3.1 This Agreement will be valid for a period of 3 years until it is expressly terminated by either party on mutually agreed terms, during which period, either parties, as the case may be, will take effective steps for implementation of this MoU. Any act on the part of either parties after termination of this agreement by way of communication, correspondence etc., shall not be construed as an extension of this MoU.

3.2 Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of termination, both parties have to discharge their obligations.
